 - iii. Annual awards would be allocated as 5% of the fund. Initial funding to authorized by the division (\$30k) then through outreach to corporate sponsors.

Potential to provide funding to the school and have them award (versus SME reviewing candidates)? Details to work out if we have the support to move forward.
