# HEALTH & SAFETY COMMITTEE INDIVIDUAL EXCELLENCE AWARD

### **Guidelines and Procedures**

NOMINATIONS	Nominations for the Health & Safety Individual Excellence Award require the following information:  1. Completed nomination form including demographic and contact information for both the nominee and the principal nominator.	
	2. <b>Required:</b> One letter of support detailing the nominee's qualification for the award. Should address qualities that are mentioned in the guidelines. Should focus on quality over quantity introducing the candidate to the committee (1 page).	
	<ol> <li>Not required: Up to four additional letters emphasizing the candidates qualifications for the award. (quality over quantity) (1 page each).</li> </ol>	
	4. Nominee's biography (2 page maximum).	
	5. Nominee's CV/resume (abbreviated version – 3 page maximum).	
	6. List of papers/publications (abbreviated version $-3$ page maximum).	
	7. Appropriate award citation.	
	All nominations submitted will be considered active nominations for a period of three years.  Nominations must be submitted in accordance with the guidelines provided on the award nomination form, which may be downloaded here: <a href="mailto:smenet.org/awards-recognition">smenet.org/awards-recognition</a>	
ADMINISTRATION	The Health & Safety Individual Excellence Award is administered by a subcommittee of SME's Health & Safety Division under the direction of the SME Board of Directors. The Health & Safety Awards Subcommittee members are selected annually by the chair of the Health & Safety Committee.	
	<ul> <li>A minimum of three nominations need to be received and evaluated for each award in order to select a winner.</li> </ul>	
	<ul> <li>Current members of the SME Board of Directors, SME Division Executive Committees, Award Committees, or Foundation Board of Trustees are NOT eligible for any awards that they are responsible for approving during their term, with the exception of "past chair" recognitions.</li> </ul>	
	No person is eligible to receive more than one SME or SME/AIME award in a single year.	
SELECTION OF RECIPIENTS	Recipients of the Health & Safety Individual Excellence Award shall be selected by a majority vote by the Award Committee, subject to the approval of the SME Board of Directors. The award need not be presented in any given year if a suitable candidate is not agreed upon.	
AWARD	The Health & Safety Individual Excellence Award shall be recognized via certificate or plaque.	
PRESENTATION OF AWARD	The Health & Safety Individual Excellence Award will be presented at SME's Health and Safety Division Breakfast held in conjunction with the SME Annual Conference & Expo.	
FUNDING	All expenses incurred with respect to the Health & Safety Individual Excellence Award shall be the financial responsibility of SME and the Health & Safety Committee.
